New West has already found the perfect new location to expand and open up a high school. The building is located in West Los Angeles at 1905 S. Armacost, only blocks away from their current location on Pico Boulevard. This new space will allow New West to expand their student body from 340 middle school students to a full capacity of 875 students by 2015.
